CAMA-X AND FIREBIRD VS. MSSQL

First off let me just say, you do not need Microsoft SQL Server for CAMA-X. In fact, unless you had to use it, I'd recommend against it. We have received many phone calls asking about hardware specifications for MSSQL. We ask them, "Why don't you use Firebird?" They say, "What are you talking about?" Everyone seems to think they are required to get MSSQL server. To get the most updated hardware requirements go to :www.camavison.com and view the [Hardware Specs](#).

Let me put it this way. Firebird is a small, easy to maintain database server, whereas MSSQL is a huge program that almost requires a Database Administrator to maintain. Also, and an important point here, CAMA-X runs Faster on Firebird.

Don't think that Firebird is a newcomer either. It was derived from Borland Interbase, which has a 20 year history. It is very popular overseas, and in the United States. There are many huge companies using it including the United States Army, Boeing, MCI, NASA, now Vanguard Appraisals and possibly you.

Let's talk money...

MSSQL requires that you purchase licenses. I am not 100% sure how it works, but I think it's like this:

- 1) You must own Windows 2000 or 2003 Server. There are two different products: One is Windows 2000 and the other is Windows 2003 Server.
- 2) You purchase "MSSQL Server Standard Edition" and license it as \$ per CPU or \$ per user.

Firebird is much easier. It's free. It runs on Windows 2000, 2003, XP, Windows 200x Server, Linux, FreeBSD, Solaris, Mac OSX and maybe some others.

To test the speed, I ran a convert from paradox to each database. Each test was run on the same computer, using the same paradox tables and the server ran locally.

- * On MSSQL, the convert took 21 minutes. (The server process allocated about 123 MB).
- * On Firebird, the convert took 18 minutes. (The server process allocated about 2 MB).

That is not too bad, pretty close actually. But, of course, that is only inserting data. What would happen if we did a revaluation, which has to load data then turn around a save it back out?

I also did a revaluation, on the same data (both databases have the exact same data), on the same computer. CAMA-X and the server were both local on my workstation.

MSSQL Revaluation Statistics:
Start time: 12/10/2004 9:55:53 AM
End time: 12/10/2004 11:29:28 AM
Process time: 1 hour 33 minutes
Parcels per second:
(7,424 pcls/5,615 seconds) = 1.3222

Firebird Revaluation Statistics:
Start time: 12/10/2004 12:21:55 PM
End time: 12/10/2004 12:27:14 PM
Process time: 5 minutes
Parcels per second:
(7,424 pcls/318 seconds) = 23.3459

This is 5 minutes vs. one and a half hours of process time. Now, I am not going to put the blame entirely on MSSQL. Everyone knows it is not that bad. There must be some hoops that CAMA-X has to jump through to get MSSQL server to run faster. But I don't know what sort of voodoo to do, nor do I have a lot of time to study the problem. CAMA-X doesn't do anything advanced or special, and Firebird handles things just fine, so why doesn't MSSQL?

The last point I would like to make is, if you use MSSQL, we would not be able to help you administer the database. It is way too complex, and no one here has had any training. Firebird on the other hand is an install and forget server. It requires next to no administration, and if problems do arise we should be able to help you.

Upgrade Advisor CD – When Can I Use It?

At the Annual User Group Meeting each jurisdiction should have received a CD in one conference packet. This is the “CAMAvision Upgrade Advisor CD.” At the meeting, we told the clients that you SHOULD be on CAMAvision version 8.0 when you run it. Actually you can run it on your computer now BUT be aware you MUST run it again after you install the update for version 8.0. The problem that it will help with is checking the content of your data tables or the structure of them. Not only are there calculation changes in version 8.0 but there are also table structure changes. So yes, you may run the CD on your current system but you will HAVE to run it on your computer system again after installing the update to CAMAvision version 8.0. 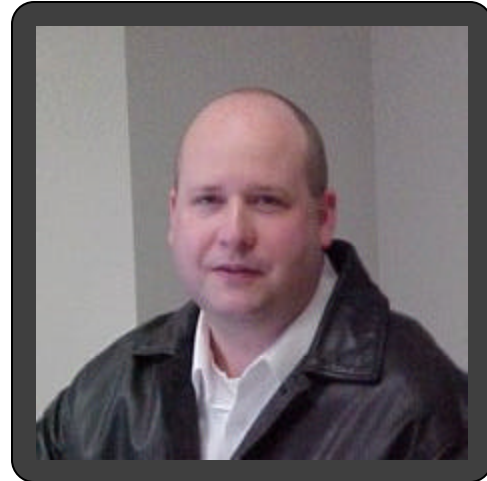
An article at Globetechnology.com offers a ‘bug free surfing zone’ utilizing the Firefox software.
